**I. CREDIT AGREEMENT:**

The applicant, through the undersigned agent, agrees the endorsement of this agreement does not obligate Perdue AgriBusiness LLC and its Subsidiaries to accept an order for direct delivery to the applicant. Further, the applicant agrees to the following conditions of sale:

**A. Credit Requirements/Invoice Terms**

The applicant agrees to abide by the credit requirements and invoice terms extended to the applicant by the Perdue AgriBusiness Credit Department. The Perdue AgriBusiness Credit Department reserves the right to modify the customer credit requirements and invoice terms without notice as conditions warrant.

**B. Invoice Discrepancies**

The applicant agrees to notify the Perdue AgriBusiness Broker / Salesperson prior to the invoice due date to discuss invoice discrepancies. The stated invoice amount is to be paid in full unless a deduction is approved by the Perdue AgriBusiness Broker / Salesperson

**C. Shipping or Product Discrepancies**

Discrepancies include, but are not limited to: late delivery of product, product quality, quantity and type of product that did not meet order specifications and product damaged during shipment.
